1. John Elizarde (Office of the Inspector General) – Human Trafficking 101

Sgt. John Elizarde was employed with the Texas Attorney General's Office from 2002-2019. During that time, Sqt. John Elizarde worked in the Crime Victim's Services Division, Executive Administration and the Criminal Investigations Division (CID). Within CID, Sqt. John Elizarde was assigned to the Special Investigations Unit. In this unit Sgt. John Elizarde conducted human trafficking and various other types of criminal investigations. Sgt. In December 2019, Sqt. John Elizarde joined the Jonestown Police Department, as an Investigator. In December 2021 Sgt. John Elizarde joined the Office of Inspector General - TJJD. Sgt. John Elizarde holds a Bachelor of Business Administration and a Master Peace Officer Proficiency Certification. Sqt. John Elizarde is a volunteer for the Texas Law Enforcement Peer Network, holds a Mental Health Officer certification, and is currently enrolled in a Clinical Counseling Master's Program.

2. Brent Puente (Texas Alcoholic Beverage Commission) – TABC Operations & Involvement of Minors

Mr. Brent Puente started his law enforcement career as a Jailer with the Willacy County Sheriff's Department in 1995 and was promoted to Deputy Sheriff in 1998. In 2002, he left the sheriff's department to pursue a career as an Agent with the Texas Alcoholic Beverage Commission.

She began her career in Montgomery County, Texas, after graduating from the Police Academy in 2003, and she remains actively commissioned with the City of Oak Ridge North Police Department. Throughout her career, Katie has focused on public safety, particularly in traffic safety and education.

Her expertise extends beyond Texas, where she provides traffic safety training at both state and national levels, supporting her fellow officers and enhancing community safety. 4. Nelda Rodriguez (University of Texas Rio Grande Valley) – Whose Mental Health Problem is it Anyway?
